Additionally, should any suit or claim be filed against the Granada Hills Homeowners Association, the Granada Hills Swimming Pool Committee, and any other related or affiliated organization, or any of their said representatives, agents, board of directors, or members, I hereby promise to indemnify and hold harmless any and all said groups and persons incurring expenses arising out of or related to any claim or expense in answering or defending suits, and any and all alleged or resulting liability which may be caused by of arise, directly or indirectly, out of the negligent use of, or acts or omissions in and around, the Pool Area by me, my family, or my guests. This indemnification and hold harmless agreement, in addition to the other covenants set forth herein, I understand and promise to abide by.

Granada Hills Pool Rules and Safety Guidelines

1. Pool hours are as posted. Check the calendar for special holiday hours.
2. Members must have key FOB to enter pool. **No FOB, no swimming, unless wearing a day-use wristband.**
3. Children 8 years old and under must be accompanied by a responsible adult (18 years or older). Swimming ability must be initially proven to the lifeguard for unaccompanied children ages 9 - 12. Supervision of children who cannot swim is the responsibility of the parent or adult guardian (18 years or older).
4. Children between the ages of 9-17 that are swimming without a parent during life guard hours are required to sign in with the guard and give a parents contact information.
5. Disturbing behavior and/or horseplay will not be allowed. Continual offenders will be suspended from the pool by the lifeguard. Parents will be notified and, before reinstatement, parents and offenders must meet with the lifeguard and/or pool manager / pool committee.
6. No running in the pool area.
7. Inflatable toys and flotation devices must be approved by the lifeguard.
8. Adult lap swimming is 15 min. before the hour, during swim break. All other swimmers under the age of 18 must be out of the pool during this time.
9. No glass containers. No food on the pool deck.
10. Babies and toddlers must use a plastic diaper cover or tight fitting toddler suit with elasticized openings. Diapers or loose fitting trunks alone are insufficient and can lead to pool closings with "accidents".
12. With the exception of private parties:
 - 1) Members may not have more than two (2) adults or one (1) family as guests at any time unless wearing day-use wristbands.
 - 2) Guests may not be residents of Granada Hills or Granada Estates.
13. Children under the age of 9 must be accompanied by an adult at all times.
